

Our Work and Service Areas


We focus our efforts on investing and leveraging funds to Help People in Crisis, Strengthen Families, and Prepare Youth to Succeed serving the towns of Ansonia, Derby, Oxford, Seymour, and Shelton.

Our Community Investments

Grants and designations totaling \$258,650 distributed to 91 organizations, including 16 local partner agencies and 71 other non-profits and United Ways.

Gross campaign increased 6% while designations decreased by 34% year-to-year.


Management, general and fundraising expenses reduced by 35% year-to-year.
